A Message From Our Executive Director

On behalf of Safe Homes of Orange County, I am pleased to present our 2015 Annual Impact Report. The Annual Impact Report takes a look at the services we provided, our fiscal health, and acknowledges the amazing donors and funders who supported us throughout the year.

In 2016, Safe Homes will continue to offer all the highlighted services and seek opportunities to enhance them for the safety of our clients and the advancement of our mission. The past

year has been extremely busy and exciting. While the need for services has not decreased and the impact of domestic violence, teen dating violence, and human trafficking is felt far beyond the county lines, we have been very fortunate to receive funding to expand our services to sexually exploited youth. In late fall, the Orange County Department of Social Services received funding to address commercially and sexually exploited youth in Orange County. Safe Homes was originally able to support a part-time positon with this funding, however as we move into 2016 we are fortunate and grateful to be expanding the position to fulltime. This position will be co-located in the Department of Social Services and will work collaboratively with many agencies within the county to identify, intervene, and support vulnerable youth in our community. In addition to providing direct support to victims, this positon will chair the Safe Harbor Task Force and provide training throughout the County. Stay on the lookout for upcoming trainings and awareness building campaigns throughout the year.

In October Safe Homes received funding to expand our therapeutic counseling services from one full-time therapist to two full-time therapists. This could not have come at a better time. This service is relatively new to our agency and the program grew quickly. The additional funding from the Office for Victims of Services (OVS) and Senator Bonacic allowed Safe Homes to expand the project, and increase the number of clients that could benefit from this service.

Safe Homes is excited to report that we are closer than ever to moving forward with a new shelter in Orange County. As we mentioned in last year's annual report, this will add 20 additional beds to our current 17. As our capability increases, so will our operating costs and our need for additional, steady financial support. We are going to need your support now more than ever. We are going to need the creative thinking, giving hearts and hands, and voice of the community to bring this all together. We cannot do this work alone and rely deeply on the unwavering support of so many within the community.

It's hard to believe that we will be honoring 30 years of service this October. In so many ways we have come so far from our beginning at the kitchen table of a private home. Yet, the concerns and strategies remain the same: How do we continue to address the growing need for our services? How do we find sustainable, on-going support? What are the most pressing needs of victims? The discussions have evolved over the years and yet there is always one constant that remains the same: no matter what we do--or how we do it--it **must always** be client-centered. It must always represent the voice of the victims and survivors among us. We must always continue to work every day in hopes that one day we will no longer be needed.

I would like to personally thank each and every one of you that supported Safe Homes of Orange County in any way this past year. We know how valuable time is and the financial constraints on so many. Thank you for making Safe Homes and the work that we do your priority. My hope is that this report contributes to a better understanding of the work we do every day and may inspire others to get involved. For now, we walk forward one foot in front of the other, together with each of you, arm in arm. We build our network, we grow our circle.

2015 COMMUNITY IMPACT REPORT

Surviving domestic violence can be a daunting, unrelenting journey. We are humbled and honored to serve those who turn to Safe Homes as their passage to safety and a life free from violence and abuse. Here we sample the impact of our work throughout 2015, made possible by our funders and supporters. Safe Homes services are accessible through a variety of **Non-Residential** and **Residential Programs**, which include crisis intervention, risk assessment and safety planning, advocacy, case management, counseling support groups, and much more.

During 2015, **Safe Homes Advocates** provided services to **730** adult clients and **580** children through **Non-Residential Programs**, and **55** adults and **50** children through our **Residential Program** for a total of **4,689** nights of safety in our **17-bed Emergency Shelter**.

Advocacy & Support Services



Thank you for all the help you provided during my stay. I am grateful for everything and can't thank you enough for teaching me how to be a stronger person. **3,070 Hotline Calls** offered safety planning and access to support services and resources.

5,507 Supportive Counseling services were provided to victims/survivors, creating **3,165** individualized **Safety Plans**.

15,700 Advocacy Services encompassed the areas of court accompaniment, legal support, law enforcement, medical, mental health, social services, housing, employment, immigration, economic empowerment, and education.

2,259 Emergency Services addressed immediate needs of children and basic needs as food, clothing, personal care, and critical household items.

Client exiting Safe Homes shelter

132 referrals for our **Therapeutic Counseling Program** provided counseling to

92 individuals with 567 sessions being provided.

141 Support Groups were facilitated and offered in English and Spanish.

Community Collaborations

Worked collaboratively with **Child Protective Services** caseworkers on **500** cases involving indicators of domestic violence, reported child abuse and participated in **78** joint home visits.

Partnered with the **District Attorney's Office** to provide assistance on **98** Grand Jury cases, advocated for survivors with Assistant District Attorneys (ADA's) on **302** occasions, and received **36** referrals from ADA's for Safe Homes services.

As part of the **Orange County Safe Harbor Initiative**, in collaboration with the **Department of Social Services** received **58** referrals for youth identified as being at risk or experiencing trafficking (September to December).

Within the **Department of Social Services (DSS)**, the **Domestic Violence Liaison** conducted **267** domestic violence and waiver assessments for applicants of DSS assistance and provided **323** waivers to enable survivors to safely comply with DSS requirements throughout the application process.

In partnership with Legal Services of the Hudson Valley, Safe Homes Family Justice Center housed a full-time attorney and paralegal who handled 143 cases, assisting clients with orders of protection, custody, visitation, divorce, and child and spousal support.

Safe Homes Volunteers contributed a total of 708 hours of service.

Outreach & Education

Safe Homes offers free education on issues surrounding teen-dating violence, violence prevention, and healthy relationships to community groups, schools, workplaces, law enforcement agencies, healthcare, government, and human service organizations. Trained educators design presentations or workshops according to the needs and characteristics of each group or audience, in English and in Spanish.

137 presentations reached 3,373 adults raising awareness on topics such as the dynamics of domestic violence, stalking, technology safety, human trafficking, the impact of domestic violence on children, and domestic violence in the workplace.

Safe Homes Teen Dating Violence Prevention Program held 318 age-appropriate presentations reaching **5,128** adolescents and teens. Topics included abusive versus healthy relationships, physical and online bullying, the impact of stereotypes, sexism, bystander intervention, and other cultural-competency themes.

Safe Homes Youth Educators led the 4th annual Youth Leadership Academy over two weeks in July for students ages 14-17. With support from the Orange County Youth **Bureau**, Safe Homes offered two academies, one in Newburgh and one in Port Jervis, with a total of **30** Orange County youth participating. During this training youth exercised and enhanced their leadership skills while agining knowledge and participating in conversations on teen dating violence, equality, safety, respect, healthy boundaries, consent, messages from the media, systems of privilege and oppression, bystander empowerment, communicating effectively, what makes a true leader, and how to make a difference in their own community. Youth were challenged to think outside the box, to challenge themselves, and to challenge others.

On February 7, 2015 we announced the winner (pictured right) of our 1st annual Safe Love is ... Art Show and Scholarship Contest. With the sponsorship of The Law Office of Benjamin Greenwald, 39 students from across Orange County (grades 9-12) submitted artwork expressing their often used by an abusive partner to manipulate and control. vision and voice in ending teen-dating violence for a chance to win the \$500.00 scholarship.






